

Rent and bond payment application form

If you don't have enough money to pay your bond and rent in advance payments, you may be able to get help from the Ministry of Social Development to meet these costs. You will need to pay this money back.

To get help with these costs you must meet certain qualifications and obligations. We will give you a call to discuss these things once we receive your completed form from your social housing provider.

If you meet the qualifications, we will make arrangements with you to pay it back over a period of time. We will pay the bond and any rent in advance payments straight to your social housing provider.

How to fill out this form	Use this form to apply for help with paying your bond and rent in advance that will go to your social housing provider. You will need your housing provider to fill in a section of this form to confirm the details are correct.
What to do when there is more than one person on the Tenancy Agreement	If there is more than one person on your Tenancy Agreement, the other person will need to fill out their own form if they need to pay part of the bond and rent in advance. If you have a partner and they are also on the Tenancy Agreement, your partner will need to fill out their own form if they need to pay part of the bond and rent in advance.
